In consideration of the premium charged, it is understood and agreed as follows:

That sub-paragraph 8(3) of Section E – General Provisions, Definitions and Exclusions does not apply, if all of the following occur:

- 1) A Transportation Network Driver is operating a Transportation Network Automobile that is insured under this policy while logged onto a Transportation Network for the purposes of accepting requests for transportation services for compensation from prospective customers, but not while the Transportation Network Automobile is also onroute to provide transportation services for compensation nor while carrying passengers for compensation as part of the services of a Transportation Network Company;
- 2) The driver of the Transportation Network Automobile is a Declared Driver who has been authorized by the Transportation Network Company to use the Transportation Network Automobile to provide prearranged transportation of passenger(s) for compensation through the use of a Transportation Network;
- 3) The driver of the Transportation Network Automobile holds a valid driver's license for a class authorized by Nova Scotia law to operate the Transportation Network Automobile;
- 4) You have informed Us and have kept Us informed as to all Transportation Network(s) You are using to facilitate the arrangement of transportation services for compensation;
- 5) The Transportation Network Company has Insurance Coverage which complies with the minimum insurance requirements for Transportation Network Automobiles stipulated by Nova Scotia law;
- 6) The automobile(s) insured under this policy that are used as Transportation Network Automobiles are also insured under a Transportation Network Company policy;
- 7) The Transportation Network Automobile is not being used as a taxicab, public omnibus, livery, jitney, site sighting conveyance or delivery vehicle.

For the Purposes of this Endorsement the following Definitions Apply:

- 1) "Declared Driver(s)" means only those driver(s) that:
 - upon application to Us, have been disclosed in Section 5 of the Nova Scotia Application for Automobile Insurance (N.S.A.F. 1) as driver(s) of the described automobile; or
 - after the inception of the policy, have been disclosed to Us by You as being driver(s) of the described automobile(s).
- 2) "Insurance Coverage" means a Standard Automobile Form Transportation Network N.S.P.F. No. 9 issued by an insurer licensed to write automobile insurance in the province of Nova Scotia and which provides the minimum insurance required for Transportation Network Automobiles as stipulated by Nova Scotia law.
- 3) "Transportation Network" means any online enabled application, digital platform, software, website, or system offered, used or operated by a Transportation Network Company and that is used by persons to prearrange the transportation of passenger(s) for compensation in a Transportation Network Automobile.
- 4) "Transportation Network Automobile" means the described automobile, a newly acquired automobile, or a temporary substitute automobile used to provide prearranged transportation of passenger(s) for compensation through the use of a Transportation Network.

- 5) "Transportation Network Company" means a corporation, partnership, sole proprietorship, association or other entity or individual that offers, uses or operates a Transportation Network exclusively to connect passenger(s) with Transportation Network Drivers for prearranged transportation.
- 6) "Transportation Network Driver" means a Declared Driver authorized by a Transportation Network Company to use a Transportation Network Automobile to provide prearranged transportation of passenger(s) for compensation through the use of a Transportation Network.
- 7) "You" or "Your" means the insured(s) named on the Certificate of Automobile Insurance.
- 8) "We" or "Us" means the insurer.

If more t	han one automobile is i	insured under this po	olicy, this endorse	ment shall apply	\prime only to the au	utomobile(s) de	scribed under	: Item(s)
